

Note :

1- All Addl. Principal Chief Conservator / Chief Conservator of Forests shall exercise financial powers of the head of department given in book of financial powers, Volume-I, subject to work distribution.

2- The powers of Addl. Principal Chief Conservator / Chief Conservator of Forests, Conservator, Divisional Forest Officers and Sub Divisional Forest Officers shall also be exercised by officers of equivalent rank in Project Tigers, National Parks, Sanctuaries, Working plan offices and Training Institutions of the department.
